If only 300,000 households participate, only \$3,075,000 is accounted for, what happens to the other \$1,125,000?	precise, the conservative approach to ensure that payment is available for all who join is to use the 2011 census data for Saskatchewan households. Once the program has launched, MMSW will assess its financial status and determine the most appropriate course of action which could include directing the funds to the program's reserve.
Questions about the MMSW program and eligibility	
If we have one bin per a rural municipality and an urban municipality; does only one municipality submit for per household payment for both municipalities?	If the urban and rural municipalities each have resident accessibility to recycling and the tonnes can be weighed and reported (they do not need to be separated), the UM and RM need to decide who will apply for these households – one can apply for both or each can apply and split the tonnes proportionately by household count. The same household cannot be counted by more than one local government and/or regional waste authority.
Our RM has one bin located in the shop yard of an adjacent RM to service households located near the RM boundary. Will that bin still qualify for funding?	Yes. One RM needs to count these households, so you need to decide which RM submits these households. Each RM can submit their proportionate share of households and report the proportionate tonnes. The same household cannot be counted by more than one local government and/or regional waste authority.
We have Crown Shred who picks up residential recycling and they invoice us according to number of households and provide us with the metric tonnes collected. Do we qualify?	Yes. You will sign the Agreement and put Crown Shred on Appendix 2 as your sub-contractor.
If we don't process our own paper and have a contractor i.e. Loraas that picks up recycling from residents, do we qualify for this program?	Yes. You will sign the agreement and discuss with Loraas who reports for your local government – you will report or Loraas will report on your behalf.
Were the recycling contractors (Loraas, WYWRA etc.) consulted in regards to the type of information they would need to provide for the communities they service? For example: Appendix 1 - General Policies and Procedures for Collectors & Processors, who is the authorized signing authority for a	MMSW's program had a consultation period prior to the first program plan being submitted. Also, all service providers were contacted by MMSW last year in preparation for the launch.

How will single-stream curbside recycling customers separate paper from other products recycled?	You will deliver single stream collection to your processor. It is likely the processor will sort the materials to send to end markets, but you should discuss this in advance with your processor to ensure that you can report the tonnes of residential WPP shipped to recycling end markets by type of packaging and type of paper and by recycling end market.

If residents in our community have the option of going to a collector for curbside pick-up without the Municipality knowing, would we have to ask the provider how many have paid for this? Because our municipality offers depots but not curbside pick-up?	You will need to know the tonnes collected by the provider and the number of households in order to receive payment from MMSW for the curbside collection.
Why are you dividing by total households in Saskatchewan-they are not all participating the program?	At this time, we do not know how many local governments and First Nations will join the program, so we need to make financing available that accounts for all households in Saskatchewan, since WPP is supplied throughout the entire province.
From your experience, is it worthwhile for a Rural Municipality with a population of approximately 650 residents, with 2-3 drop off depots, to consider a program like this?	Yes. Depot recycling is a good choice for small communities. Recycling is able to be done through depots that have good signage to direct the resident.
District is under a depot site system and not door to door - does this make a difference?	No, the collection channel does not make a difference. You will be paid based on the number of households with access to the depot and you will report the actual tonnes you collect, etc.

Is Crown Shred considered a subcontractor?	Yes, they collect and process recycling, so they can be a sub-contractor.
Can we partake if we use Loraas to pick up the recycling but charge the cost of recycling to the residents?	The intent of the program is to offset the cost of recycling WPP to your residents. You can apply to the program and use the monies to help pay for your residential recycling of WPP.
Would Crown Shred be considered an end user if all material is sent to them for distribution?	No. Crown Shred is considered to be the processor and they would sell your materials to an end market.
If a municipality is a member of a RWA, does it fill in App. 2 delegating the RWA as their "Contractor"?	If a municipality delegates their RWA, the RWA will be signing the agreement, and you will provide them with authorization separate from this agreement. You do not sign the Services Agreement.
Does the LG service agreement have to be received by you or is the RWA form identifying members with attached LG appendices sufficient?	If a municipality designates their RWA, the RWA will be signing the agreement, and you will provide them with authorization separate from this agreement. You do not sign the Services Agreement. The RWA must submit and sign the completed agreement.
Can a municipality designate an RWA as a contractor or do they have to run the agreement through them?	Yes, a municipality can designate a RWA as a sub- contractor; the RWA will need to provide the required weight and information for the municipality to report to MMSW.
If our local government will be represented by a RWA, is the local government signing anything? Or is that all done by the RWA?	Once the local government gives the RWA permission, likely in writing, to act on their behalf, the local government does <u>not</u> sign the agreement with MMSW. In this case the RWA signs the agreement with MMSW.
We have a joint agreement with our Rural Municipality to provide a recycling depot. We cost share the recycling program 50/50. Can I just include these households on the agreement that the Village is submitting? Do you consider a RWA a municipality's subcontractor if they are collecting the materials as well as accepting them?	Only one entity can receive payments for each household. If you share a depot with an RM, you will need to discuss and decide with the RM how many households you are each requesting payment for, and who is reporting on what percentage of the collected recyclables. Both the village and the RM may choose to sign with MMSW, or one may grant the other permission to act on their behalf. The RWA can be a sub-contractor for full service (collection and processing). The RWA will need to provide the required weight and information for the municipality to report to MMSW.

If the Town does not collect any recycling from IC&I locations as they contract directly from Loraas, what do we record in this box?	Provided that Loraas does not mix the IC&I collection with residential –if Loraas collects any residential on behalf of the town – you do not need to report the number of IC&I locations. It is only if residential and IC&I are mixed collection when weighed that the number of IC&I locations need to be reported.
We use Loraas, they pick up from some small businesses in our community. Any ideas on how we will be able to sort commercial vs residential when they are all provided the same bins?	You will need to ask Loraas for the number of IC&I locations that they service. MMSW will deduct the amount of IC&I WPP on a proportionate basis to the number of IC&I locations to residential locations.
