

### Terms and Conditions for MMSW Low Volume Stewards - Effective January 1, 2017

1. You have read and agree to all the terms listed below.
2. You understand that **italicized words** and other important steward information is [available here](#) and in the National Stewards Guidebook (<http://guidebook.cssalliance.ca/>)
3. You are the Primary Contact for your company.
4. You agree to maintain accurate contact information on the WeRecycle portal.
5. Your business has residency in Saskatchewan as defined in the National Stewards Guidebook.
6. You agree to become a member of Multi-Material Stewardship Western Inc.'s (MMSW) Waste Packaging and Paper **Stewardship Program Plan** as a low volume steward as per the conditions outlined on the MMSW website.
7. You appoint MMSW as your agency to carry out your duties as a steward under the Saskatchewan Household Packaging and Paper Stewardship Program Regulations (**Regulation**) and understand that MMSW will act in the best interests of all Members as a whole.
8. You agree that MMSW shall assume your duties as a steward under the Regulation.
9. You acknowledge that you and MMSW will both use reasonable diligence and care to prevent the unauthorized disclosure, reproduction or distribution of information considered private and confidential (such as customer, technical, financial and other business information received from the other) to any other person.
10. The information and sales or other data you used to identify your low volume category is complete and accurate.
11. You understand that once you have confirmed submission of your report, you will not be permitted to change the flat fee category you have selected (please be sure you have selected the correct category prior to submission).
12. You agree to submit your low volume steward report for each **Reporting Obligation Year**, according to the dates and policies posted on the MMSW websites.
13. You understand and agree that your company must retain supporting documentation for five years from submission date and that your report may be subject to audit.
14. You agree to receive and pay invoices based on the preferences you selected when setting up your account on WeRecycle portal, and as per the payment due dates on your subsequent invoices.
15. You understand and agree that you may be charged interest of 4% per annum above the Canadian Imperial Bank of Commerce's (CIBC) prime lending rate on any late payments.
16. You understand that membership is on an annual basis and that you may terminate membership by giving written notice to MMSW by May 1<sup>st</sup> of any calendar year and that you must within thirty (30) days of notification, submit complete payment for the remainder of that calendar year.
17. You understand that if you provide written notice of your termination in the program after May 1<sup>st</sup> of any calendar year, your payment obligations noted in item #16 above will continue for the remainder of that year, plus the following calendar year.
18. You understand that if the Plan is rescinded by the Ministry of the Environment, you are permitted to withdraw from the MMSW plan without any penalty and will be responsible for the pro-rated fees as per the date of your exit.
19. You agree that any disputes between MMSW and you shall be made under the dispute resolution process that is published on the MMSW website. Referral of any disputed matter shall not act to stay or defer your obligations to pay the flat fee.

**Definitions:**

**“Regulation”** means the Saskatchewan Household Packaging and Paper Stewardship Program Regulations Chapter E-10.21 Reg. 5 (effective February 15, 2013), as amended from time to time [posted here](#).

**“Reporting Obligation Year”** means the calendar year for which a member is required to report to MMSW, based on data from your previous calendar year

**“Stewardship Program Plan”** means MMSW’s Waste Packaging and Paper Stewardship Plan as approved by the Ministry of the Environment [posted here](#).
